The Marine Corps-Law Enforcement Foundation (MC-LEF) provides educational assistance to the children of fallen United States Marines and federal law enforcement personnel. Since our founding in 1995, MC-LEF has awarded over **\$76 million** in scholarships and other humanitarian assistance, and supported over 4,000 recipients.

MC-LEF relies on the commitment of volunteers and generous donors across the country, who organize events, provide financial support and recruit others to our cause. With only one part-time employee, MC-LEF is sustained by a network of people who believe that the brave men and women who protect our country and our communities deserve to have their families protected as well.

Thanks to our generous donors, MC-LEF is currently able to place a \$35,000 savings bond in a scholarship account for every child who loses a parent serving in the United States Marine Corps or any federal law enforcement agency. In recent years, we have expanded our mission to provide medical equipment and financial support to catastrophically wounded Marines, as well as financial support for mentally or physically disabled children of active duty Marines. In the past, MC-LEF has also aided the children of other military personnel who perished in terrorist attacks and in the wars in Iraq and Afghanistan.

MC-LEF is an approved IRS 501 (c) 3 organization that has been recognized for its excellence and efficiency by the Independent Charities of America. 98% of all donations to MC-LEF go directly to fund our mission.

2018 Year in Review

As we think about this past year, we are constantly reminded of the incredible generosity of our supporters and the amazing work of our volunteers. Together you allow us to continue our most important work of supporting those families of Marines and Federal Law Enforcement Officers.

In 2018, we held Galas in New York City, Atlantic City and Philadelphia; a dinner in Dallas (attended by more than 200 supporters), Golf Outings in Scottsdale, Atlantic City, central and south Jersey, New Haven, Long Island and Las Vegas and fielded teams in both the Marine Corps and New York City Marathons. The funds raised during these events together with our donor's contributions help support our mission of "Educating the Children of Those Who Sacrificed All".

To put that into perspective, this year we will have helped 129 recipients, 75 of whom will have received \$30,000 Educational Accounts. We have also helped 13 Federal Law Enforcement families disbursing over \$137,000 in Humanitarian Aid. Finally, we have disbursed over \$73,000 in Medical Assistance primarily in the form of DocBand Helmets for the young children of our Marines. For 2018, we have given over \$2.6 million to the children and families of Marines and Federal Law Enforcement Officers.

Since our founding in 1995, we have helped 4,056 recipients and disbursed over \$75.7 million in aid. We couldn't have achieved this success without your support. During this Holiday Season we would like to extend our most heartfelt gratitude for your efforts and generosity and wish you all a healthy and Happy New Year.

The 20th Anniversary of the Marine Corps-Law Enforcement Foundation's Annual Philadelphia Gala was held at the SugarHouse Casino on Saturday, 27 October 2018.

Medal of Honor recipients Brian Thacker and Mike Thornton played with both committee members and sponsors. Medal of Honor recipient Tom Kelley and his wife, Joan, joined the group for lunch. USMC Generals Ron Coleman, Willie Williams and Craig Crenshaw linked-up as well. Later that evening, our honored guests, sponsors and committee members were treated to a wonderful spread by the Malta Boat Club and Mission BBQ. Although the weather was inclement, the internal climate was festive.

The night began in the spacious perimeter hallways adjacent the SugarHouse Ballroom with the cocktail hour, along with beau coup hors d'oeuvres. SGT Major Green's 35 year career began in 1983, shortly after the bombing, 23 October in Lebanon where 305 American and French peacemakers were killed. And before the official national airing in November 2018, the SGT Major portrayed the recruiting Marine video that touched everyone. SGM Green spoke of all the current serving Marines under his tutelage, their commitment, esprit de corps and determina-

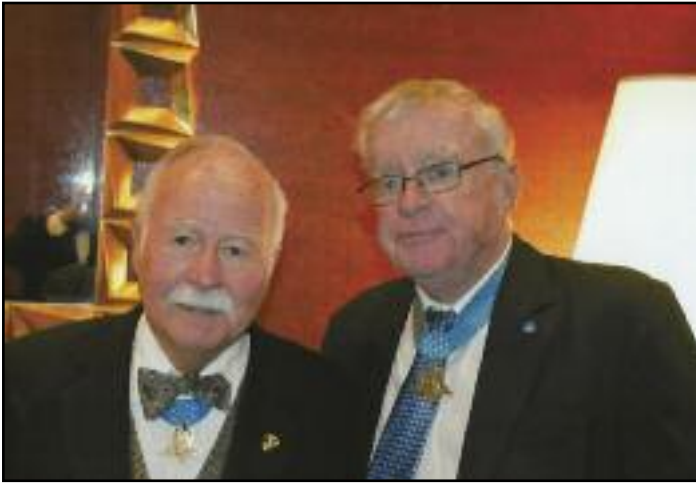

37th Annual GySgt John Basilone Memorial Parade September 23, 2018

RARITAN BOROUGH - The life and legacy of John Basilone, the hometown hero who was awarded the Medal of Honor for heroism during World War II, was celebrated Sept. 21-23 with a series of special events.

Besides the 37th Annual John Basilone Memorial Parade on Sunday, the events began Friday with the official renaming of the post office on E. Somerset Street as the "Gunnery Sergeant John Basilone Post Office."

The events continued Saturday with the first "No Excuses: Manila Madness 5K" race, sponsored by the Basilone Memorial Foundation, through borough streets.

Basilone died in battle on Iwo Jima 73 years ago. He had returned to combat after becoming the only enlisted Marine to receive the Medal of Honor and Navy Cross in World II for his actions on Guadalcanal when he manned a machine gun to hold off thousands of Japanese soldiers.

Thousands come to Raritan every year for the parade, the only parade in the United States to honor a war hero.

The parade started at 1 p.m. at the train station then marched to Somerset Street for a ceremony at the Basilone statue. The parade featured military groups and veterans organizations, floats, high school marching bands, Boy Scouts, Girl Scouts, ROTC units, Civil Air Patrol cadets, fire departments, rescue squads and other civic groups.

Andy Martin, a Vietnam veteran who was awarded a Silver Star, the third highest honor that can be bestowed for bravery, served as the grand marshal and retired Marine Lt. Gen. John Toolan was the featured speaker.

Martin, a star basketball player at Bridgewater-Raritan High School in the mid-1960s, was awarded the Silver Star for his actions in close combat in Vietnam in May 1969. His actions allowed seriously wounded soldiers to be evacuated safely from the battlefield.

Toolan's final post was commanding general of the Marine Corps in the Pacific. He served in the Persian Gulf war, the 2003 Iraq war and Afghanistan.

Before the parade the public was able to view the Basilone collection at the Raritan Library and St. Ann Church celebrated a memorial mass.

Leading the 5K race was Marine veteran Rob Jones who lost his legs in a landmine explosion in Afghanistan.

Since that time, Jones has dedicated himself to raising public awareness of the challenges faced by troops wounded in action. He took a solo bike ride across the country to raise money for organizations supporting veterans and followed that by racing in 31 marathons in 31 days in 31 cities.

Race proceeds will benefit the Robert Wood Johnson University Hospital Steeplechase Cancer Center/RWJ Barnabas Health and the Fischer House Foundation for Veterans.

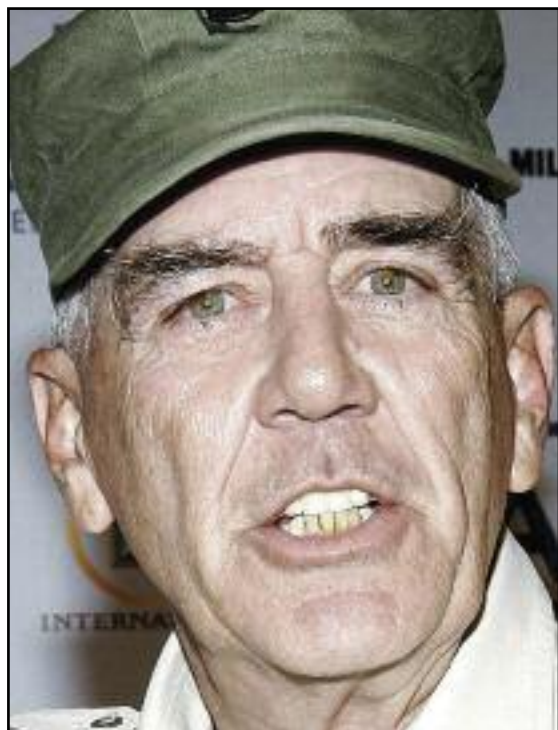

Marine, 'Full Metal Jacket' actor R. Lee Ermey buried at Arlington National Cemetery

ARLINGTON, Va. (FOX 5 DC) - Legendary Marine and actor R. Lee Ermey was buried with full military honors at Arlington National Cemetery, section 82, on Friday, January 18.

Ermey, who turned his experience as a Marine Corps drill instructor into a notable role in the Academy Award-nominated 1987 film “Full Metal Jacket,” was laid to rest months after his passing.

Ermey died on April 15, 2018, at age 74 due to complications from pneumonia. Before Ermey, veteran, skyrocketed to fame for playing Gunnery Sergeant Hartman in “Full Metal Jacket,” he served 11 years in the Marines, including a tour as a drill instructor, 14 months in Vietnam and then on Okinawa, where he was promoted to staff sergeant prior to being medically discharged in 1972 for injuries he received during his service, according to Stars and Stripes.

He went on to appear in several notable films including “Mississippi Burning,” “Dead Man Walking,” and “Toy Story,” and hosted “Mail Call” on the History Channel.

I now have a trike. It's just what I needed, and I love it!

As anyone with a spinal cord injury will tell you, in the aftermath of that injury, you begin to try to collect the pieces of your former life together and get as close as you can to whole.

Since childhood, my heart has always found a home in the freedom of the outdoors. I cannot convey how important the outdoors has been to me and how immense of a void it has become post-accident. When I see ridge lines and benches

and mountain tops from my vehicle, especially the ones that I used to disappear onto, it brings tears to my eyes. It's one of the rare things, in my new condition, that brings genuine sorrow to me: the inability to stand and walk and climb in those wild places. I can't get out there in the way that I used to, almost daily, but now I can still get out there. It's a piece that's coming back together thanks to the Marine Corp-Law Enforcement Foundation. Feels the **WEIGHT** of History

How did it feel to help carry former President George H.W. Bush's casket into the Capitol? Ask this Marine from Tampa Bay. Cpl. Kevin Harris, a 24-year-old New Port Richey native, was one of eight service members to carry the former president's casket into the U.S. Capitol Monday evening.

Marine Cpl. Kevin Harris felt the weight of history on Monday as he helped pull the flag-draped casket out of the gleaming black hearse. "Wow," the 24-year-old New Port Richey native recalled thinking at that moment. "This is the 41st president of the United States." Harris was one of eight U.S. military service members who carried former

President George H.W. Bush's casket into the U.S. Capitol. Bush, who died Friday at age 94, was set to lie in state at the Capitol until 10 a.m. Wednesday, and then Harris and his counterparts lifted his casket again to carry it lockstep back to the hearse. "It was a pretty humbling opportunity and feeling to have," Harris told the Tampa Bay Times on Tuesday. "I never thought in my life that I'd be put in that situation."

Harris is part of the Marine Corps Body Bearers, an eight-person unit tasked with carrying the caskets of Marines and their family members who are buried in the Washington, D.C. area. The unit also serves senior statesmen, heads of state and

former presidents. Bearers from other branches joined Harris and another Marine on Monday for Bush's ceremony. Harris said he and his fellow Marines often take part in several funerals a day. Most of them don't draw the attention of the entire nation. But he couldn't worry about that pressure. "You can't let anything affect you because it's not about your pain," he said. "You're doing that service for the members of the family ... It's the least we can do to honor them in the best way possible before we let them down one last time." That meant locking in, staring straight and breathing only through his nose. He and the other bearers also had to withstand the physical

strain of carrying the several-hundred-pound casket from the hearse, up the Capitol steps and into the building's rotunda — all with one arm each.

To build up that endurance, Marine bearers train underground in the solemn bottom level of a parking garage, Harris said. They practice hauling every kind of casket imaginable and grind through workouts. The caskets they carry typically weigh between 400 and 800 pounds, said Harris, who was selected by the Corps to start training with the unit in 2016, a year after joining the Marines. At funerals, composed bearers give onlooking relatives a sense of dignity, he said. "We're that last representation of something their family member was a part of," he said, "something they probably loved a lot." The presidential ceremony was different than most, of course. But Harris approached it like any other, he said. If he had started thinking about all the people watch-

ing — like former President George W. Bush, whom Harris passed by inches — he might've messed up. He didn't, and from Florida, his parents watched with pride. "My wife and I were crying, watching him on TV," said his father, 55-year-old Mike Harris, a retired New York City police officer. "It's a monumental event, and our son is there." The younger Harris graduated from River Ridge High School in 2013, where he played football and hockey. He has always been a leader, his father said. Harris was looking forward to helping carry the president back to the hearse Wednesday morning for the drive to the National Cathedral for his state funeral. "Just doing it right. Just making sure I execute it perfectly for President Bush and his family," he said. Someday, he hopes a few Marines will do the same for him.

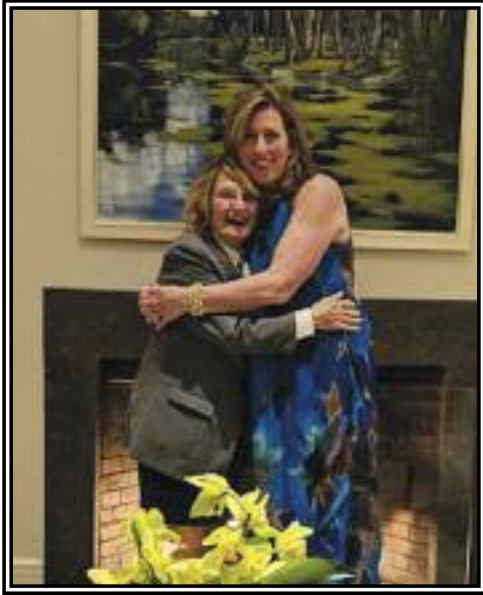

'Consummate Professional,' MOH Recipient Barnum Receives Lone Sailor Award

WASHINGTON – Medal of Honor recipient Harvey C. "Barney" Barnum Jr. has received a fair share of awards and recognition in his lifetime. Apparently, it doesn't get old.

Three months ago, the retired Marine colonel learned he was one of two people selected to receive the 2018 Lone Sailor Award.

He was floored by the news, as a feeling of complete surprise and shock hit him. It was similar, he said, to what he felt two years ago, when he learned that the Navy decided to name a destroyer after him.

"I got to tell you, I had the same unbelievable sensation throughout my body as I had when Secretary of the Navy Ray Mabus called and said he was going to name a destroyer the Harvey C. Barnum, Jr. You know, how could this be happening to me?" Barnum recalled.

The Navy Memorial honored Barnum last week, during its annual Lone Sailor Awards Dinner, a posh, black-tie event with 500 guests in attendance. Navy veteran Bill Hannigan, a former AT&T president and chief operations

officer, was the other award recipient. Hannigan served in the Navy as a radioman for six years before leaving the service as a first-class petty officer.

Barnum, 78, joked that "it takes three men and a work party to lift" the award, a bronze 15-inch-tall statue of the iconic Lone Sailor bundled up in a Pea coat and sporting the distinctive round Dixie cup hat that junior enlisted sailors wear.

In a press release from the U.S. Navy Memorial, Retired Rear Adm. Frank Thorp, president and chief executive officer of the memorial, called Barnum the "consummate professional who earns the respect and admiration of everyone he meets." In selecting awardees, the Navy Memorial considers veterans of the Navy or Marine Corps who have drawn upon their "Sea Service experience" to distinguish themselves in their subsequent careers and lives.

In 1965, then 1st Lt. Barnum demonstrated tremendous courage after enemy fighters ambushed his unit, mortally

wounding the company commander and killing the radio operator. According to the Navy Memorial release, Barnum jumped into action, leading a counter-attack against overwhelming odds, charging a small hill and firing a rocket launcher at enemy positions. He also ordered his men to blow up a section of trees to make a clearing while he radioed for helicopters to come extract the casualties.

When word came that the helicopters couldn't land, Barnum stood in the clearing open to hostile fire and radioed back "If I can stand here, by God, you can land here," according to the release.

For his bravery and heroic actions that day, Barnum was awarded the Medal of Honor in 1967. He then volunteered for a second tour to Vietnam. He retired from the military after 27 years of service with numerous other awards, including the Purple Heart and Bronze Star with the combat valor device. Barnum then held many high-ranking

positions as a civilian in the Defense Department.

Once the Arleigh-Burke class destroyer Harvey C. Barnum is commissioned, estimated to occur in 2024, Barnum said he will include the Lone Sailor statue as one of his personal mementos he plans to give to the ship. He also wants to give back what he can to the crew to show his appreciation for the honor bestowed upon him.

"To be recognized by your Navy and Marine Corps team is pretty awesome," said Barnum who plans to offer his mentoring services to the crew.
